- One candidate needed for each position. -

#### **(6-year term; elect 1)**

**Albert Armstead**, member of Bayside Midtown Covenant Church, Sacramento CA. Experience: Founder and CEO of my company, To The Hoop Basketball Services. For the past thirty years my responsibilities have included training, marketing, developing, and basketball consulting. I have worked with over 200 NBA players and countless, high school, college, and overseas players as well as coaches and teams.

*Personal Statement: While I grew up in church and while there are a long line of preachers and pastors in my family's lineage, I didn't fully commit my life to the Lord until I was in college. It was at that time that I understood*

*the difference between religion and relationship. I realized that salvation wasn't based upon works, who I knew, my family history, or anything other than what Christ had done for me personally. It was only through the saving work of the cross that my sins were paid for and forgiven. It was at this point that I began to form an intimate and personal relationship with God through the ups and downs and high and lows of my life.*

#### **(6-year term; elect 1)**

**Byron Kaopuiki**, member of Cascade View Covenant Church, Vancouver, WA. Retired. Experience: 30+ years of engineering, design, manufacturing, and technical publications for underground mining heavy equipment followed by working 13 years in printing and publishing in a K-12 school district. I currently serve as chairman of the Cascade View Covenant Church (CVCC) leadership team and am in the middle of my second 6-year term. I am also the ministry leader of our "Aloha Team" (church greeters) and have responsibilities for Hospitality, Ushers, monthly communion service preparations, and any other special services we may have.

*Personal Statement: “As a child, I was raised in the Catholic Church. I never understood about a personal relationship with Jesus until I was 25 yrs. Old, when I accepted Christ as my Savior. In my 40+ years as a born-again Christian, I have experienced Christ's love and many blessings towards me and my family. I am by no means a Bible scholar, but my faith is strong.”*

#### **(2-year term; elect 1)**

**Bryan Murphy**, lead pastor of South Bay Community Covenant Church, Freemont, CA. Experience: 10 years full-time ministry experience. Executive Certificate in Religious Fundraising and training in church revitalization. Serve on the PSWC Pastoral Care Commission and as the campus chaplain for James Logan High School.

*Personal Statement: “Growing up in a strict Christian household and attending college in the Midwest, my fundamental beliefs about God/Christ were not really challenged until I moved to California in my early 20s. By this time, I had fallen away from my Christian roots and was challenged by the exposure to so many people with such a varied understanding of God (e.g. Buddhist, Muslims, etc.). I read up on the various religions and examined a few but never really felt they connected me to God. Then one day, due the death of my girlfriend's grandmother, I attended a Christian church service. God ignited a passion for His Word in me that day. Within a year, I had read the Bible cover to cover and was hungry for the truth revealed in the Bible. Several months after the initial church service, the pastor delivered a message in which he described Jesus as God extending His hand of love*

and friendship. At that moment, I understood what it meant to accept salvation and have a personal relationship with God.”
